

GREENWOOD COUNTY COMMISSION MEETING  
FEBRUARY 22<sup>ND</sup>, 2022

Chairman Roy Ballard called the regular meeting of the Greenwood County Commissioners to order at 9:00 a.m. Other members present were Ben Fox, Chuck Spradlin, Paul Hodge, Robert Morgan, County Counselor Paul Dean and County Clerk Kathy Robison.

Commissioners led everyone present in the Pledge of Allegiance.

*Spradlin moved to approve February 14<sup>th</sup>, 2022 Minutes, as written. Fox seconded. Motion carried 5-0.*

Road and Bridge report:

- Crews are working to remove a hedge row for a land owner on 60<sup>th</sup>.
- Darrell reported having seen a 2013 Ford on Federal Surplus in the amount of \$23,000.

*Ballard moved to approve the purchase of said vehicle in the amount of \$23,000. Morgan seconded. Motion carried 5-0.*

- KCAMP is slated to look into the truck that was recently involved in a rollover accident.

*Ballard moved to approve a motion to pay employees outright for 'snow days', in which the courthouse and county buildings were closed due to inclement weather. Fox seconded. Motion carried 5-0.*

*Morgan moved to approve payables in the amount of \$409,631.43. Hodge seconded. Motion carried 5-0.*

*Fox moved to approve payroll in the amount of \$123,000.23. Morgan seconded. Motion carried 5-0.*

*Fox moved to approve special payables in the amount of \$254.16. Morgan seconded. Motion carried 5-0.*

Levi Vinson provided commissioners with Resolution 22-02 regarding mutual aid to neighboring counties.

*Fox moved to approve Resolution 22-02. Spradlin seconded. Motion carried 5-0.*

Interim Noxious Weed Director Jennifer West provided commissioners with the Noxious Weed Management Plan for signatures.

Register of Deeds Marsha Ramsey provided commissioners with an employee verification for Chasity Zeckser as Deputy Register of Deeds at a pay rate of \$14.50 per hour.

*Fox moved to approve hiring Zeckser at a pay rate of \$14.50 per hour for the full-time position of Deputy Register of Deeds. Morgan seconded. Motion carried 5-0.*

*Hodge moved to adjourn at 9:38 a.m. Morgan seconded. Motion carried 5-0.*
