Commissioners led everyone present in the Pledge of Allegiance.

Hodge moved to approve November 22, 2021 Minutes as written. Morgan seconded. Motion carried 5-0.

Hodge moved to approve November 29, 2021 Minutes as written. Spradlin seconded. Motion carried 5-0.

Road and Bridge report:

- Fox moved to approve hiring Larry Greenwood at a pay rate of \$13.00 per hour for recycling.
 Hodge seconded. Motion carried 5-0.
- Crews have finished the grinding projects that were ongoing.
- Shell Rock is slated to open Thursday of next week to allow time for curing.
- Truck 5 is ready for pick up in Chanute.
- The recycle truck is slated to be finished with repairs this week.
- Darrel is currently gathering information for pricing of a skid steer. Commissioner Ballard recommended looking into a CAT.
- The Road and Bridge Department should receive a check from FEMA in the near future for the Landfill Bridge.
- Darrel informed commissioners that the department is still looking for a check from the Federal Exchange that was reportedly sent out on October 11th, 2021 in the amount of an estimated \$70,000.
- Ballard reported he had received calls regarding the approach that has washed out near Bitler Bridge.
