

GREENWOOD COUNTY COMMISSION MEETING
MAY 3RD, 2022

Vice Chairman Ben Fox called the regular meeting of the Greenwood County Commissioners to order at 9:00 a.m. Other members present were Roy Ballard via Zoom, Chuck Spradlin, Robert Morgan, County Counselor Paul Dean and Deputy County Clerk Deann McCaffree. Commissioner Paul Hodge was not in attendance.

Commissioners led everyone present in the Pledge of Allegiance.

Spradlin moved to approve April 25, 2022 Minutes as written. Morgan seconded. Motion carried 4-0.

Road and Bridge Report:

- Spradlin reported that 99 HWY is currently closed.
- Crews are currently working on trimming trees.
- Chrisman is slated to look into the purchase of a couple of trucks at an upcoming auction; he asked commissioners to authorize up to \$90,000 toward the purchase of such a vehicle.

Spradlin moved to approve the purchase of a truck for the Road and Bridge Department in the amount of up to \$90,000. Morgan seconded. Motion carried 4-0.

- Chrisman reported that the department has had issues with the AC unit at the Road and Bridge Building.

Spradlin moved to approve the cost of a new AC unit for Road and Bridge in the amount of \$5,956.30. Morgan seconded. Motion carried 4-0.

- Fox informed fellow commissioners that a cement slab located near 210th and BB road needs to be addressed, as Quincy township has stated that it does not have the funds to repair said slab. Commissioners are slated to look into the matter.
- Commissioners discussed providing two loads of gravel to Lyons Park to repair potholes.

Morgan moved to approve payables in the amount of \$231,452.97. Spradlin seconded. Motion carried 4-0.

Morgan moved to approve payroll in the amount of \$121,140.57. Spradlin seconded. Motion carried 4-0.

Register of Deeds Marsha Ramsey provided a report regarding an ice machine for the courthouse that was discussed at a previous meeting. Ramsey reported that a vending company would like to visit the courthouse for a walk-through. Maintenance Supervisor Greg Rawlings reported that he has briefly looked into the matter. He found a machine for approximately \$400 to \$600. Rawlings stated he will delve further into the matter and provide a more thorough report at a later date.

Rawlings next reported that Oklahoma LED has started upgrading lights in county buildings.

Fox reported that Rock's 54 Tire would like to rent blow-up play areas for children to utilize during Eureka days and would like to place them on the courthouse lawn. Commissioners voiced no opposition.

Spradlin moved to approve \$50 towards the purchase of flowers and \$50 towards the Cancer Society for Kathy Robison's mother's funeral service. Fox seconded. Motion carried 4-0.

Spradlin moved to approve a five-minute executive session to discuss legal matters with legal counsel Paul Dean. Fox seconded. Motion carried 4-0. Meeting reconvened at 9:50 a.m. No decisions were made.

Spradlin moved to adjourn at 10:05 a.m. Ballard seconded. Motion carried 4-0.

Spradlin will not be in attendance for the commission meeting on Monday, May 9th, 2022.
