Commissioners led everyone present in the Pledge of Allegiance.

Commissioner Fox made a motion to approve the minutes of November 6, 2023, Commissioner Obourn seconded. Motion carried 5-0.

Road and Bridge report:

Road Supervisor, John Schouten presented bids.

Commissioner Obourn made a motion to approve the cattle guard bid for \$3,200.00. Commissioner Hodge seconded. Motion carried 5-0.

Commissioner Obourn made a motion to approve the Tadpole bridge bid for \$5,372.00. Commissioner Hodge seconded. Motion carried 5-0.
