Obourn moved to approve proceeding with the mapping project. Ballard seconded. Motion carried 5-0.

McCaffree informed commissioners three bids were received for the year end dinner. TNT Catering with a bid of \$16.00 per plate. Teresa Gulick with a bid of \$18.00 per plate. Hamptons2 LLC with a bid of \$35.00 per plate.

Fox moved to approve TNT caterings bid of \$16.00 per plate for the year end dinner. Obourn seconded. Motion carried 5-0.

Membership for the Kansas Natural Resource Coalition was revisited, Obourn defined how they help local, state and federal government.

Obourn moved to approve membership and membership dues for the Kansas Natural Resource Coalition in the amount of \$5,000.00. Hodge seconded. Motion carried 5-0. (JE24-112)

Lindsev informed commissioners she had hired a temporary part-time biller for the Health Department.

Obourn moved to hire part-time Health Department biller, Beverly Signer at \$20.00 hr. Ballard seconded. Motion carried 5-0. (JE24-113)

Commissioners decided to hold the final commission meeting of the year, on December 31, 2024 at 9am.

Evenson stated he did not believe Greenwood needed to be at every commissioner meeting. Commissioners did encourage Greenwood to attend if he has something important or if a matter needed discussed.

Fox moved to approve a five-minute executive session for legal. Obourn seconded. Motion carried 5-0. Reconvened at 10:37. No decisions.

Evenson moved to adjourn at 10:37. Hodge seconded. Motion carried 5-0.
