

GREENWOOD COUNTY COMMISSION MEETING

FEBRUARY 18TH, 2025

Mac Obourn called the regular meeting of the Greenwood County Commissioners to order at 9:00 a.m. Other members present were Roy Ballard, Ron Mast, Judd Everitt, Preston Evenson, County Counselor Paul Dean and County Clerk Deann McCaffree.

Commissioners led everyone present in the Pledge of Allegiance.

Evenson moved to approve February 10th, 2025 minutes as written. Mast seconded. Motion carried 5-0.

Road and Bridge Report:

- Road and Bridge Administrative Assistant, Kassadie Lazar informed commissioners that a vinyl decal is being designed and made for Road and Bridge vehicles. Lazar noted they should be done within the week.
- Lazar presented a sealed bid to commissioners for work needing done at Bakers Crossing.
- Evenson questioned the cost to dump household trash. Lazar stated it had increased from \$3.00 - \$5.00, to \$15.00. (JE25-18)
- Two bids were presented from Ramsey Concrete for Bakers Crossing approaches. Bid #1 in the amount of \$29,400.00, which is based on engineer specs. Bid # 2 in the amount \$34,500.00 included improvements Ramsey Concrete owner, Drew Ramsey suggested. (JE25-16)

Evenson moved to approve Bid # 2 from Ramsey Concrete in the amount of \$34,500.00. Everitt seconded. Motion carried 5-0.

Evenson moved to approve special payables in the amount of \$8,685.71. Mast seconded. Motion carried 5-0.

Evenson moved to approve payables in the amount of \$194,345.30. Mast seconded. Motion carried 5-0.

Mast moved to approve payroll in the amount of \$159,170.98. Evenson seconded. Motion carried 5-0.

Evenson moved to appoint Jan Bills as the Eureka Township Clerk. Everitt seconded. Motion carried 5-0. (JE25-17)

Commissioners discussed the need for hospital board members. Greenwood County Hospital CEO, Sandra Dickerson informed commissioners that she had someone who showed interest in being on the hospital board. Dickerson asked that commissioners revisit the topic after the upcoming Hospital board meeting.

Ballard revisited the request for funding from the Madison Fire Department to help with the purchase of a rescue truck. Emergency Management Director, Levi Vinson noted that in the past the commission had decided that any city that purchased a pumper truck and helped with fires in the county, the county would spend up \$15,000.00 to help with the truck.

Evenson moved to approve giving \$15,000.00 to Madison Fire Department Relief Association fund. Everitt seconded. Motion carried 5-0.

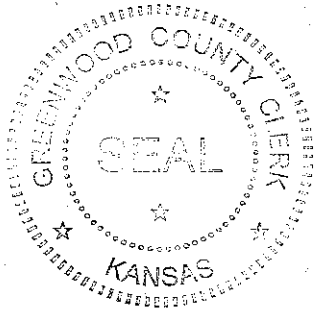
