Mac Obourn called the regular meeting of the Greenwood County Commissioners to order at 9:00 a.m. Other members present were Roy Ballard, Ron Mast, Judd Everitt, Preston Evenson, County Counselor Paul Dean and County Clerk Deann McCaffree.

Commissioners led everyone present in the Pledge of Allegiance.

Evenson moved to approve February 18th, 2025 minutes as written Everitt seconded. Motion carried 5-0.

Road and Bridge Report:

 Road and Bridge Administrative Assistant, Kassadie Lazar informed commissioners she only had 7 township members RSVP for the annual Township meeting/dinner, the deadline to RSVP is Thursday February 27, 2025. Commissioners stated that at least twenty people needed to RSVP in order to have the dinner.

Evenson moved to approve special payables in the amount of \$3,069.99. Ballard seconded. Motion carried 5-0.

Evenson informed commissioners that, Maintenance Supervisor, Greg Rawlings was searching for tiles to match what is in the court house, to replace the ones taken out during the sewer project. Evenson noted that Rawlings is salary, but would like Rawlings to receive comp time for the extra hours worked and working Presidents Day to complete projects.

Evenson moved to approve 4 days of comp time to offset extra time worked on the sewer project. Everitt seconded. Motion carried 5-0.

Greenwood County Fire Chief, Glen Collinge informed commissioners Madison fire truck #166 had to be rewired, the cost for repairs is \$2,340.12. Collinge requested approval to purchase six rims and six tires for miniature tanker being built for Fall River Lake fire.

Evenson moved to approve \$2,340.12 for repairs to the Madison fire truck and \$3,190.00 for six tires and six rims for the Fall River fire tanker truck. Ballard seconded. Motion carried 5-0.

Ballard recommended the next time a six-by-six truck is purchased, that starters and alternators should be replaced soon after purchase to avoid issues with wiring.

Emergency Management Director, Levi Vinson presented the annual Noxious Weed Eradication report to commissioners and requested approval and signatures. Vinson noted that at this time there is not a Noxious Weed Director, but ads had been placed for the position.

Obourn moved to approve the annual Noxious Weed Eradication report. Everitt seconded. Motion carried 5-0.

Obourn moved to approve a ten-minute executive session with Sheriff, Heath Samuels for legal. Ballard seconded. Motion carried 5-0. Reconvened at 9:37. No Decisions.

Former commissioner, Paul Hodge informed commissioners he had received complaints regarding no guardrails on Canyon Hill.

Obourn mentioned a letter received from Greenwood County Rural Water District #2 regarding the annual meeting. (JE25-19)

Everitt moved to adjourn. Evenson seconded. Motion carried 5-0.
