*Obourn moved to approve a \$2 per hour raise for new payrate of \$17.00 per hour. Everitt seconded. Motion carried 4-0*

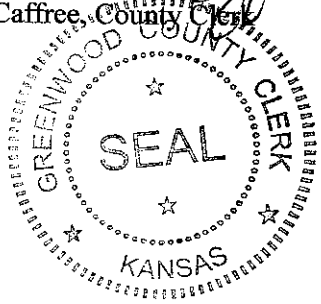
*Evenson moved to adjourn at 10:17a.m. Everitt seconded. Motion carried 4-0.*
