Commission Chair, Mac Obourn, called the regular meeting of the Greenwood County Commissioners to order at 9:00 a.m. Other members present were Roy Ballard, Ron Mast, Judd Everitt, Preston Evenson, County Clerk Deann McCaffree and County Counselor Paul Dean.

Commissioners led everyone present in the Pledge of Allegiance.

Evenson moved to approve June 23rd, 2025 minutes as written. Everitt seconded. Motion carried 5-0.

Road and Bridge:

- A. Greenwood presented new hire Mary Cathell for Road Grader operator starting at \$17 hr
Ballard made a motion to approve the new hire Mary Cathell for \$17hr. Mast seconded it motion carried. 5-0
- A. Greenwood brought up about the bridge on BB 75 Road south of 400. Contacted FEMA and they said it would be more money in the end.
- A Greenwood talked about the Barricade and cone signage quote for intersection changes.
- Obourn brought up Reece Rd he wants A Greenwood to get started on the road.
- Ballard brought up 190th St / DD bridge needs to be looked at for repair.
- Ballard reported the Pedroja bridge was washed out again 375th and Y Rd.

Obourn motion to purchase from national Signage at \$6,080.00 and Everitt second it. Motion carried 5-0.

- Evenson questioned the chip/seal and said get quote from APAC for chip sealing.

- Obourn asked for the Resolution 2025-38 to reappoint Appraiser Griffiths 7/1/2025-6/30/2029.

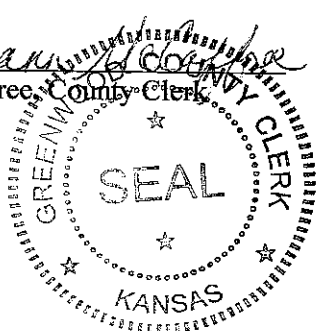
Evenson moved to approve Resolution 2025-38 four-year appointment for Appraiser Shawna Griffiths
