- Eureka City Resident Approached Commissioners about culvert across from county-Ambulance-fire barn and its in the city responsibility not county.

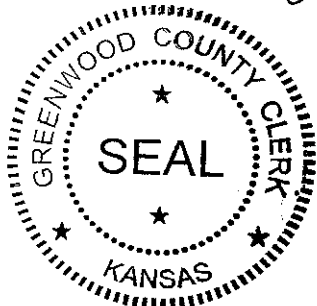
**Everitt moved to adjourn at 9:40a.m. Ballard seconded. Motion carried 5-0.**



