# GREENWOOD COUNTY COMMISSION MEETING AUGUST 4<sup>TH</sup>, 2025

Commission Chair, Mac Obourn, called the regular meeting of the Greenwood County Commissioners to order at 9:00 a.m. Other members present were Roy Ballard, Ron Mast, Judd Everitt, Preston Evenson, County Clerk Deann McCaffree.

## Road and Bridge:
