Commission Chair, Mac Obourn, called the regular meeting of the Greenwood County Commissioners to order at 9:00 a.m. Other members present were Roy Ballard, Ron Mast, Judd Everitt, Preston Evenson, County Counselor Paul Dean, and County Clerk Deann McCaffree.

Commissioners led everyone present in the Pledge of Allegiance.

Everitt moved to approve October 20th, 2025 minutes as written. Mast seconded. Motion carried 4-0. Commissioner Evenson did not vote.

Road and Bridge:

• Road and Bridge Supervisor Allen Greenwood let the commissioners know that 2 bridges did not pass state inspection last Tuesday. Greenwood said they have one fixed but have not heard back at this time if it now meets the requirements. Greenwood also let the commissioners know that the bridge west of Commissioner Mac Obourn's house does not qualify for federal historical register. Obourn asked if there was something that can be done to fix and save the bridge. Greenwood said Michael Marris has advised the best route at this time is to tear the bridge out.

Claims:

Ballard moved to approve Special Payables for October 27th, 2025 in the amount of \$56,757.58. Everitt seconded. Motion carried 5-0.

Evenson moved to approve Regular Payables for October 31st, 2025 in the amount of \$156,084.80 Mast seconded. Motion carried 5-0.

Evenson moved to approve Regular Payroll for October 31st, 2025 in the amount of \$153,948.67. Ballard seconded. Motion carried 5-0.

New Business:

Frank McCollum discussed with the commissioners his concerns regarding the Greenwood
County Hospital no longer accepting certain Medicare Advantage Plans. Sandy Dickerson with
Greenwood County Hospital spoke with the commissioners regarding that they are still accepting
some Medicare Advance Plans just not Aetna, Humana, and WellCare because the reimbursement
does not cover to cost of treatment.

Old Business:

• County Counselor Paul Dean reported that the Kansas Department of Health and Environment has signed off on the tax sale. Dean said the sale is scheduled for December 17, 2025 at Memorial Hall to begin at 10 a.m.

Obourn motioned for a 10-minute legal executive session with County Counselor Paul Dean and Road and Bridge Supervisor Allen Greenwood regarding county line road dispute and hedgerow encroachment. Evenson seconded. Motion carried 5-0. Returned at 9:37 a.m. No decision.
