Commission Chair Preston Evenson, called the regular meeting of the Greenwood County Commissioners to order at 9:00 a.m. Other members present were Roy Ballard, Ron Mast, Judd Everitt, Mac Obourn, County Counselor Paul Dean, and County Clerk Deann McCaffree.

Commissioners led everyone present in the Pledge of Allegiance.

Obourn moved to approve March 16, 2026 minutes as written. Mast seconded. Motion carried 5-0.

Clerk's Agenda:

- County Clerk Deann McCaffree presented on behalf of Health Department Supervisor Jayme Lewis a bid of \$3,896 for new computers.

Obourn motioned to approve the bid of \$3,896 for new computers. Everitt seconded. Motion carried 5-0.

- County Clerk Deann McCaffree presented the Annual FRA Declaration form to be signed that was brought to the office by Linda Snyder. This was signed by the Chairman of the Board.

Vinson did let the commissioners know that longevity pay increase of 3% was noted in the pay scale.
