Commission Chair Preston Evenson, called the regular meeting of the Greenwood County Commissioners to order at 9:00 a.m. Other members present were Judd Everitt, Roy Ballard, Ron Mast, Mac Obourn, County Counselor Paul Dean, and County Clerk Deann McCaffree.

Commissioners led everyone present in the Pledge of Ailegiance.

Everitt moved to approve March 9th, 2026 minutes as written. Mast seconded. Motion carried 5-0.

Claims:

Ballard moved to approve Special Payables for March 16, 2026 in the amount of \$2,358.24. Everitt seconded. Motion carried 5-0.
