Commission Chair Preston Evenson, called the regular meeting of the Greenwood County Commissioners to order at 9:00 a.m. Other members present were Judd Everitt, Roy Ballard, Ron Mast, Mac Obourn, County Counselor Paul Dean, and County Clerk Deann McCaffree.

Commissioners led everyone present in the Pledge of Allegiance.

Mast moved to approve May 4th, 2026 minutes as written. Mast seconded. Motion carried 5-0.

Road and Bridge:

- Administrative Assistant Kassadie Lazar presented new hire verification for Road Sign & Labor position for Walker Wade @ \$15.45/hour.

Obourn moved to approve employee verification for Walker Wade. Mast seconded. Motion carried 5-0.

Ballard moved to approve employee verification for Taelyn Huffman. Obourn seconded. Motion carried 5-0.

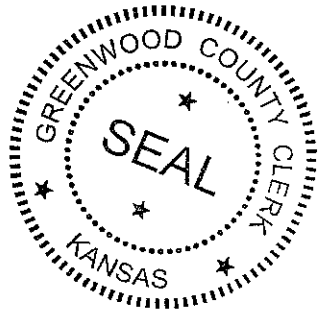
Executive Session:
